CALL TO ORDER - The Governing Body met for a regular meeting and the following commission members were present in the commission chambers: Mayor Holly Pittman, Mayor Pro Tem Nancy Bauder, Commissioners Edd Hingula and Jermaine Wilson. Absent: Commissioner Griff Martin

Consideration of Previous Meeting Minutes:

Commissioner Wilson moved to accept the minutes from the April 8, 2025 regular meeting. Commissioner Bauder seconded the motion and the motion was unanimously approved. Mayor Pittman declared the motion carried 4-0.

Open Public Hearing:

Commissioner Bauder moved to open the public hearing. Commissioner Hingula seconded the motion and the motion was unanimously approved. Mayor Pittman declared the motion carried 4-0.

Review of Properties by Staff and Public Comments:

Chief Building Inspector Hal Burdette reviewed the 3 properties. All three properties were damaged by fire and the City has received insurance proceeds to be used to either remove the structures if the owner decides not to repair them, or the money is returned to the property owners once repairs have progressed to a reasonable point. Comfortable with providing 90 days for property owners to demolish the structures or make repairs to them.

- 224 Miami St. City Staff have spoken with the owner, who intends to make repairs. The owner has selected a contractor who should be applying for a permit soon.
- 1425 Grand Ave. City staff have spoken to the owner in the last few weeks. The owner stated that she intends to make repairs, but staff has not received a permit application to date.
- 1933 Miami St. City staff have received a permit application for the repairs after the policy report was completed, so they are beginning the process.

Jeff Culbertson, property owner, 224 Miami:

- · Process with insurance has been slow
- Guarantee house will be fixed up and ready to move into in about 90 days
- Will probably begin getting permits in a week or so

Marissa Magana, property owner, 1425 Grand Ave.:

- Contractor has been selected
- Plan is a complete tear down and rebuild
- Timeline for total project is unknown, but hopefully torn down in 90 days

Close Public Hearing:

Commissioner Hingula moved to close the public hearing. Commissioner Bauder seconded the motion and the motion was unanimously approved. Mayor Pittman declared the motion carried 4-0.

Consider Resolution B-2395 Demolish or Repair:

Commissioner Wilson moved to approve Resolution B-2395 with the language suggested by the City Attorney. Commissioner Bauder seconded the motion and the motion was unanimously approved. Mayor Pittman declared the motion carried 4-0.

Resolutions:

Resolution B-2396 Community Development Block Grant Annual Action Plan — Planning & Community Development Director Kim Portillo and Community Development Coordinator Bradley Brandon presented for consideration the 2025-2026 Annual Action Plan. Leavenworth is an entitlement city that receives CDBG Funds and must submit an annual action plan with HUD. The report is composed of needs assessments of the community's housing stock, homelessness issues, public facilities, infrastructure, and community development assets. The award figures at this time are projected, as Congress has not voted upon the funds and once that happens HUD will advise what the award amount will be and the true total award will be updated. The Community Development Advisory Board has voted for a pro-rata configuration once the true award total is given.

Commissioner Wilson moved to approve Resolution B-2396 adopting the 2025-2026 Annual Action Plan and submission of the plan to HUD. Commission Bauder seconded the motion and the motion was unanimously approved. Mayor Pittman declared the motion carried 4-0.

Consider Approval of Resolution B-2397 and Agreement with KDOT Agreement 904-24 for the 10th and Limit Intersection Project — Public Works Director Brian Faust presented for approval Resolution B-2397 and requested the Mayor to execute KDOT Agreement 904-24 for the Traffic Signal Upgrade and Turn Lane Construction for the 10th and Limit Intersection Project. The City was awarded funding under the Highway Safety Improvements Program to make safety improvements at the intersection of 10th and Limit. While the majority of the costs are covered by the grant, the City is responsible for 10% of construction and 100% of other non-participating costs. The safety improvements include a dedicated southbound right turn lane, new traffic signals and upgraded ADA crossings. The City needs to approve Resolution B-2397 and KDOT Agreement 904-24 for this funding.

Commissioner Bauder moved to approve Resolution B-2397 and authorize the Mayor to execute KDOT Agreement No. 904-24 for the 10th and Limit Intersection Project. Commissioner Wilson seconded the motion and the motion was unanimously approved. Mayor Pittman declared the motion carried 4-0.

ISSUE:

Consider a waiver of a Transient Merchant Permit for the purpose of an Art Show as part of the Leavenworth Family Pride Picnic Event at Hawthorn Park.

BACKGROUND:

Barbara Williams submitted an application that was received in the Office of the City Clerk for June 22, 2025 to host an art show as part of this year's Leavenworth Family Pride Picnic Event at Hawthorn Park. Leavenworth Family Pride intends to invite 5-10 local artists to display and sell their artwork during the event.

All vendors have a Kansas Retail Tax number or the event coordinator will provide the vendors with a tax form to complete and return to the Kansas Department of Revenue. The City reports all events to the Kansas Department of Revenue so they can verify that taxes and any other applicable sales are submitted as required.

The City of Leavenworth Code of Ordinances Chapter 34, Peddlers, Solicitors and Transient Merchants Sec. 34-62 States:

- A transient merchant permit shall not be issued for use in or on a city-owned property including rights-of-way, parks or open spaces or the community center, provided that the city commission may grant in specific cases a waiver of this general prohibition.
- Application and request for waiver shall be on a form provided by the city clerk and submitted
 to the city clerk at least 30 days prior to the date of the activity to be placed on the agenda of
 the next regular meeting of the city commission.

The City of Leavenworth Codes of Ordinances Chapter 34, Peddlers, Solicitors and Transient Merchants Sec. 34-1 Definitions, defines a transient merchant as:

• Transient merchant, itinerant merchant or itinerant vendor are defined as any person, whether as owner, agent, consignee or employee, whether a resident of the city or not, who engages in a temporary business of selling and delivering goods, wares and merchandise within such city, and who, in furtherance of such purpose, hires, leases, uses or occupies any building, structure, motor vehicle, or public room in hotels, lodging houses, apartments, shops or any street, alley or other place within the city, for the exhibition and sale of such goods, wares and merchandise, either privately or at public auction. Such definition shall not be construed to include any person who, while occupying such temporary location, does not sell from stock, but exhibits samples only for

the purpose of securing orders for future delivery only. The person so engaged shall not be relieved from complying with the provisions of this chapter merely by reason of associating temporarily with any local dealer, trader, merchant or auctioneer, or by conducting such transient business in connection with, as a part of, or in the name of any local dealer, trader, merchant or auctioneer. A transient merchant is not a person who has a permanent business presence in Leavenworth and conducts sales or activities similar as described herein on a temporary basis.

Fee for Transient Merchants:

A Transient Merchant, Itinerant Merchant or Itinerant Vendor Permit fee is \$50.00 per day. The
permit is not to exceed 5 days; and no more than two licenses may be issued during a calendar
year.

If the City Commission should grant the waiver all applicable fees and insurance requirements would still apply, the waiver just allows the sale to be held on city property, specifically at Hawthorn Park which is prohibited by ordinance. The applicant is also required to provide a certificate of liability insurance prior to the date of the event along with any fees required by the Community Center.

ISSUES:

Consider approval of Resolution B-2398 for two special events: Moonlight Market Summer Concert Series on June 7, 2025, and Pipes & Pistons Summer Concert Series on July 12, 2025. Both events will be held at Haymarket Square and require closing Cherokee Street from 7th Street to the Water Department entrance to motor vehicle traffic. These street closures, approved by Police Chief Kitchens due to submittal of all required documentation with the new policy and successful prior use, will facilitate shopping, food, drinks, and activities within the street closure for attendees.

A resolution from the Governing Body is necessary, as per K.S.A. 41-719, to allow for the possession and consumption of alcoholic liquor within the closed street areas, outside of the immediate Haymarket Square venue.

The "alcohol friendly" area will be clearly marked within the boundaries of the events.

RESOLUTION B-2398

A RESOLUTION APPROVING SPECIAL EVENTS KNOWN AS MOONLIGHT MARKET SUMMER CONCERT SERIES AND PIPES & PISTONS SUMMER CONCERT SERIES SPONSORED BY LEAVENWORTH MAIN STREET.

WHEREAS, the City of Leavenworth, Kansas (the "City") is approving Special Events sponsored by Leavenworth Main Street known as Moonlight Market Summer Concert Series and Pipes & Pistons Summer Concert Series.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LEAVENWORTH, KANSAS:

- **Section 1.** Pursuant to state law, alcoholic liquor may be consumed at a special event to be held on designated public streets, alleys, and sidewalks when a temporary permit has been issued by the Kansas Division of Alcoholic Beverage Control (ABC) and the governing body has approved the event as required by K.S.A 41-719 and amendments thereto.
- **Section 2**. Having considered the request to allow the possession and consumption of alcoholic liquor, the governing body hereby approves the Moonlight Market Summer Concert Series event to be held beginning at 5:00 p.m. through 9:00 p.m. on Saturday, June 7, 2025, and the Pipes & Pistons Summer Concert Series event to be held beginning at 5:00 p.m. through 9:00 p.m. on Saturday, July 12, 2025, provided Leavenworth Main Street secures appropriate permitting from ABC and complies with all state laws and ordinances regulating alcoholic liquor.
- **Section 3.** A portion or all of the following street(s) shall be closed to motor vehicle traffic at appropriate times in order to accommodate the events being held during the date(s) and time(s) identified in section 2:
 - A portion of Cherokee Street from 7th Street to the entrance of the Water Department

Pursuant to K.S.A. 41-719, the sponsor shall ensure that the area in which alcoholic liquor is possessed or consumed is clearly marked by signs, a posted map or other means ("Designated Barricaded Area").

Section 4. Event attendees may purchase, possess and consume alcoholic beverages within the Designated Barricaded Area. Pursuant to K.S.A 41-719 no alcoholic liquor may be removed from the Designated Barricaded Area or consumed inside vehicles while on public streets or alleys at the event.

Setion 5. This Resolution shall take effect and be in force after its approval by the governing body.

ISSUE:

Consider approval of Resolution B-2399 to start the process for acquisition of private property for public purposes on the 10th Avenue and Limit Street Intersection Improvement Project.

BACKGROUND:

In August 2022, the City was notified by KDOT that we were eligible for up to \$1M in federal-aid HSIP funding for safety improvements at the intersection of 10th Avenue and Limit Street. HSIP is short for Highway Safety Improvement Program.

The plans for the intersection improvements identified the need for temporary easements and additional rights-of-way. Over the last month, the City, through our consultant John Amrein of The Land Company, has been working to obtain the needed easements from the property owners. While several properties have signed the easement documents, there are three (3) properties remaining where an agreement has not been reached. To avoid risking the loss of funding, the City needs a parallel condemnation process to help ensure the needed properties are obtained. City staff will continue to work with all the property owners and John Amrein to obtain signed easements throughout the process.

This project is scheduled to be bid in September; however, KDOT requires the easements/ROW to be obtained or condemnation to be initiated prior to bidding.

While easements are needed for the project, the protection of private property rights is a key "American" principle. The law allows for the government to acquire private property for public purposes with "just compensation". Kansas Statutes define the process to help ensure that the power of the government is not unreasonably applied to the citizens during property acquisition. The approval of this resolution is simply the first step of a larger process summarized below.

General Outline of Eminent Domain Actions

- 1. Government approves a resolution declaring their intent to use the power of eminent domain ("condemnation") for a specific project. This is the action recommended in this policy report.
- 2. Government adopts an ordinance identifying the legal descriptions of the property in question and the names of the owners.
- 3. After the ordinance is effective, an action is filed in District Court.
- 4. After a judge is assigned to the case, there are three (3) appraisers appointed by the judge to review the documents, inspect the property and determine the value of compensation to be paid to the owner.
- 5. The appraisers will hold a hearing where the City and the owners can talk about their concerns and the amount of compensation.
- 6. After the hearing, and assuming the judge finds the needs of the City to be reasonable, the judge will issue an order listing the value of compensation for each easement. After this value has been paid to the court by the City and recorded in District Court, the easements are available for use by the City. The City can object to any of the amounts and "not pay", but the easement will not be available for the project.
- 7. Should an owner believe the easements were undervalued, this can be appealed to the court system. It is important to note that the appeal is ONLY to the value, not the actual need for the easement.

There are costs to the City for this process. The City is responsible for its own attorney fees, filing fees, appraiser fees, and any compensation recommended by the court. The process is somewhat lengthy, and usually is complete within 60 days; however, the process may take longer.

RECOMMENDATION:


Staff recommends that the City Commission approve Resolution B-2399 regarding the appropriation of private property for public purposes.



RESOLUTION NO. B-2399

A RESOLUTION DECLARING THE NECESSITY TO APPROPRIATE PRIVATE PROPERTY CONNECTED WITH THE 10TH AVENUE AND LIMIT STREET INTERSECTION IMPROVEMENT PROJECT, FOR THE USE OF THE CITY AND AUTHORIZING SURVEYS AND DESCRIPTIONS OF LAND OR INTERESTS TO BE CONDEMNED TO BE PREPARED.

WHEREAS, the City of Leavenworth, Kansas, intends to undertake certain street and other public improvements, generally described as Leavenworth HSIP-N075(201) (the intersection of 10th Avenue and Limit Street), KDOT Project No. N-0752-01, and City Project No. 2022-980, as shown on the plan documents therefor (the "Project"), and in furtherance thereof, the City shall require certain easements and/or rights-of-way; and

WHEREAS, pursuant to K.S.A. 26-201, whenever it shall be deemed necessary by the governing body of any city to appropriate private property for the use of the city for any purpose whatsoever, the governing body shall by resolution declare such necessity and authorize a survey and description of the land or interest to be condemned to be made by a licensed land surveyor or a professional engineer who is competent to conduct a land survey and filed with the city clerk.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LEAVENWORTH, KANSAS:

- **Section 1:** That the Governing Body does hereby deem it necessary to appropriate private property for the use of the City for the purposes of rights-of-way, permanent easements, temporary construction easements, and other interests in real property to complete the Project.
- **Section 2:** That the Governing Body does hereby authorize a survey and description of the lands or interests to be condemned to be made by a licensed land surveyor or a professional engineer who is competent to conduct land surveys, the same to be filed with the City Clerk.
- **Section 3:** That the City Clerk shall cause this Resolution to be published once in the official city newspaper as provided by K.S.A. 26-201.
- **Section 4:** This Resolution shall be effective upon its adoption by the City Commission of the City of Leavenworth, Kansas.
